2. Single Audit and FY2022 Financials

Dan Burgess pointed out that on the Annual Financial Statement on first page under opinions it states there are no findings. This is the key component that you want from an audit. On page 6 & 7 under the Management Discussion there are some comparisons. It is helpful to have some comparison. On page 7, the activities statement both revenues and expenditures were increased significantly from 2021. Ridership had also increased significantly. This is a result of the continuing recovery from Covid. We are actually back to pre-Covid numbers.

Dan pointed out the Federal grants are under non-operating revenues. The State assistance is predominantly our contract assistance. There is a slight decrease in the State due to a write-off of some receivables. Federal increase substantially. Next year (fiscal year (FY) 23) there should be an increase in State assistance. We anticipate an increase in Federal as well, though not as substantial.
