3. Administrator's Report, Civil Rights Report, and Financial Report

Mary Ellen DeFrias reviewed the Administrator Report. There are still union negotiations, and we will need to hold off commenting until mediation is complete. Excited to report that the South Attleboro stations are open with limited service. GATRA is working with the MBTA and the city of Attleboro to determine how to service the station safely.

Mary Ellen attended the APTA Legislative gathering held in Washington DC last month (April). This was an opportunity to speak with staff from Senator Warren, Senator Markey, and Congressman Auchincloss's office on what all RTA's are working on, particularly GATRA. Mary Ellen discussed GATRA's new Wareham facility which will be a green facility, and all are looking forward to it. Senator Markey was pleased to hear about the new facility being green. There are no changes to the Civil Rights Report; we are still in compliance. GATRA is excited to announce our new member to the GATRA family. Kylie Araujo had a baby girl, Annie, born Tuesday, 5/14. Both mom and baby are doing well. In the interim Sharon O'Brien will fill-in while Kylie is out on maternity leave.

Dan Burgess covered the fiscal year Financial Report dated March 31. April's board meeting voted to approve amendment #2 which specifically addressed the Brokerage Services and Special Services (Blue Apple Bus) lines. There will be minor adjustments made for the final amendment addressed at May's board meeting for the FY24 budget.

4. Financial Report, Distribution of FY25 Budget

Included as an attachment in May's packet is the FY25 proposed budget. This is to allow the board enough time to review and vote at June's meeting. The biggest change is to the cover sheet. Brokerage is now separate from transit services. This is to keep a clear division between transit services and the Brokerage contract.

Despite the news about the Senate budget being generous to the RTA's, the House version was not as generous. There will be changes made during the conference committee. Due to this, the budget was based on level funding which is constant in both the Governor and House versions.

GATRA was notified of being awarded the Tri Transit grant for free service during Christmas 2024. This grant is included on the cover sheet under the Non-Federal Transit Grants.

Each page has the 4 pillars which make up the 4 different parts of GATRA – GATRA Administration, Contractor – KOA (transit service), GATRA Microtransit/COA and GATRA Brokerage.

5. Executive Compensation Committee Recommendation

The Executive Compensation Committee recommended a 5% increase for the Administrator.
