3. Administrator Report, Civil Rights Report, & Financial Reports

Mary Ellen DeFrias reviewed the January 2024 Administrator Report. She reviewed that the majority of triennial findings are completed. At this time, GATRA is waiting for the Civil Rights findings to be approved, but everything is submitted. She will be moving this item to the Civil Rights Report and providing updates there as they are received. Mary Ellen reviewed that the next GATRA public meeting will be held on January 25th, 2024 and asked the Board to share this date with their communities to provide feedback on service.

Mary Ellen reviewed the January 2024 Civil Rights Report and noted that GATRA is compliant with all Civil Rights requirements at this time.

Dan Burgess reviewed the January 2024 Financial Report. He noted that the expenses and revenues were in line with the expectation, with the exception of Brokerage Services and Special Services. These two areas are outpacing the budget in both expenses and revenues. Dan reviewed that because of this, there will be a budget amendment in the future, but that overall, the budget was in good shape.



Greg Guimond, Marshfield asked Mary Ellen to clarify the Sunday Service roll out date. Mary Ellen confirmed the date of February 5th, 2024.

Joanne Moore, Duxbury asked how GATRA plans to advertise Sunday Service. Mary Ellen said there will be service announcements on GATRA's social media and website. Joanne also noted that GATRA could send a press release to be included in Council on Aging (COA) newsletters or postings.

4. Safety Plan

Mary Ellen reviewed that the Safety Plan is required by federal law for GATRA to have in place. This Safety Plan is in addition to the Operational Safety Plan GATRA has in place with the Operator. This Plan outlines bigger picture safety concerns and considerations. The Union is also involved in creating and approving the plan before it gets to the Board. Mary Ellen reviewed that the safety plan committee reviews and approves the Plan in December and then it goes before the Board in December. She noted that there were no major changes from the prior year.

Motion to approve the GATRA Public Transportation Agency Safety Plan passed.

5. Halifax Joining GATRA

Mary Ellen reviewed that Halifax is requesting to join GATRA as a community and referenced a letter outlining this request submitted by Halifax. Mary Ellen reviewed that if the Board voted to approve Halifax to join GATRA, the next vote on the agenda would be to revise the weighted vote incorporating them in the overall vote.

Mayor O'Connell, Taunton asked Mary Ellen to review the benefits of Halifax joining GATRA. Mary Ellen discussed that adding another community, especially in that geographical region, promotes resource sharing, connectivity between communities, and better interoperability. Adding Halifax moves GATRA towards a long term goal of connecting more communities and strengthening the service that GATRA can offer in a given geographical region.

Mayor O'Connell, Taunton asked Mary Ellen to discuss challenges involved with Halifax joining GATRA. Mary Ellen reviewed that overall a shortage of drivers and vehicles are an issue. For the time being, Halifax would continue to run service as they currently are and GATRA would assist with funding. In the future, Halifax would be in the pipeline for future vehicles.

A motion was made and 2^{nd} to approve Halifax joining GATRA. A roll call vote was taken.

6. Revision to Weighted Vote

Mary Ellen introduced the Revised Weighted Vote and reviewed that as a new community, Halifax would be assigned a vote of 1.00. Once they are assessed, their weight would be adjusted based on the assessment.

Kevin Dumas, Mansfield asked why the weighted vote is based on Fiscal Year (FY) 22 assessments. Mary Ellen explained that the weighted vote is always based on a delayed FY based on when GATRA receives funding and the most current assessments available.

Patti Waitkevich, Kingston asked a clarifying question about the assessment dollar amounts. Mary Ellen reviewed that this is the amount that is paid by the community to GATRA for services.
