## 3. Administrator Report, Civil Rights Report, & Financial Report

Mary Ellen DeFrias reviewed the January 2025 Administrator's Report. She noted that some routes are being realigned to better match demand and to align better with MBTA schedules. Evening service is also being added to some routes. The Spare Dial-A-Ride dispatch system has also continued to be an asset in providing date and streamlining the Dial-A-Ride process. The new eJest vehicles are on site. They will eventually be used for service in the Wareham area when the new facility is operational, but for now they may be used to service other areas. When they are registered and ready for the road, Mary Ellen is planning to have a press conference. The construction of the Wareham maintenance facility is also ongoing. GATRA has also been involved in World Cup planning conversations.

Mary Ellen also reviewed the January 2025 Civil Rights Report. GATRA is current on all submissions. There is a Regional Public Meeting next week for service changes that would go into effect in March. GATRA is also beginning 2025 Triennial Review.



Cobi Frongillo, Franklin asked Mary Ellen if there are plans to increase service in Franklin and other communities surrounding Gillette Stadium for the World Cup and if there would be changes to the current service during that time. Mary Ellen said that at this point, anything is on the table. The planning committee is working under the assumption that many people will be staying in Providence and Boston because of the airports, but given the estimated attendance, it is likely people will be all over the state. The committee involves multiple agencies from across the state and there are many unknowns still at this point in time, but she will continue to update the Advisory Board as plans are made.

Dan Burgess presented the January 2025 Financial Report. He reviewed that budget lines are all within expectations. He noted that the funding for the airport shuttle is winding down. Brokerage Operations revenues and expenses are both higher than the budgeted numbers and will need to be adjusted in a future budget adjustment.

#### 4. State Audit Review

Mary Ellen DeFrias reviewed that a State Audit Report was issued on GATRA's electric bus program. GATRA was given the opportunity to respond to their findings, and did so, but the entirety of the response was not included in the final report. Mary Ellen reviewed each finding and gave the Board more context in each area. She emphasized that the electric buses in GATRA's fleet are all well-maintained and well cared for at GATRA. Additionally, despite one of the findings regarding cash collecting procedures being resolved before the auditors left the site, it was still noted as a finding.



Mayor O'Connell, Taunton thanked Mary Ellen for the overview and explanations. There were no further questions from the Board.

### 5. FY (Fiscal Year) 24 Financial Audit

Mayor O'Connell, Taunton reviewed that the Audit & Finance Committee met on January 9, 2025 to review the FY24 Audited Financials: FY24 Financial Statements, FY24 Single Audit Report, and FY24 MBTA Report. At that meeting, the Committee was able to ask questions to GATRA and to the Auditor directly with and without GATRA leadership present. At the conclusion of the meeting, the Committee voted unanimously to approve the above-stated reports and bring them to the full Board for approval.

Dan Burgess reviewed that there were no findings in the audit reports, meaning there were no issues or concerns from the auditors. Additionally, the audits found that GATRA was compliant with all the applicable requirements. There were no further questions.

Josie Dutil, Bellingham asked a clarifying question about the calculation and Dan referred to the weighted vote formula in Chapter 161B, the MA governing law that Transit Authorities were founded under. He clarified that the votes are points, not percentages out of 100, so the total of all the points is not meant to be equal to 100.
